ANTI-RAGGING CELL

Objectives

Anti-Ragging Cell will be the Supervisory and Advisory Cell in protecting the culture of ragging free atmosphere at Mundeshwari College for Teacher Education campus. The Cell will be involved in designing actionable plan for curbing the nuisance of ragging inside campus through different suitable activities.

Scope

Mundeshwari College for Teacher Education endeavours to safeguard the right of students to pursue their studies in a friendly atmosphere and also ensuring the same. Ragging is an act where a weak junior is victimized by a senior. Mundeshwari College for Teacher Education perceived it to be psychologically scarring for both culprit and victim students. In order to make available to its students friendly atmosphere which is favourable to study and free of fear & bullying, Mundeshwari College for Teacher Education has decided to implement the anti-ragging regulations and directives as passed by the Hon'ble Supreme Court.

- (a) The anti – ragging cell consists of:
- (i) One Senior Faculty. (Chairperson)
 - (ii) Others nominated by Principal. (Member)
- (b) Duties and Power :The anti - ragging cell shall perform following functions:
- (i) Recommend to the Principal a panel of office bearers for designing actionable plan for curbing the nuisance of ragging inside campus.
 - (ii) Consider cases of ragging and award punishment as per the rules and regulations provided by the UGC/Supreme Court/Board of Governors.
 - (iii) Regular checking through appointing Anti – Ragging Squad and same shall be communicated to the management.
 - (iv) Recommend for new initiative after consultation with the Principal.
 - (v) Ensuring the ragging free campus.
- (c) The committee shall meet as often as necessary.
- (d) A written notice of every meeting together with the agenda shall be circulated by the Chairperson of the Cell to its members at least three days before the meeting. The Chairperson may include any item on the agenda for which the notice could not be given.



- (e) The Chairperson may call a meeting at short notice whenever required.
- (f) The Chairperson shall preside over the meeting of the Cell. In his absence, the senior most members present shall preside the meeting.
- (g) The quorum for the meeting shall be one-third of its total members.
- (h) The ruling of the Chairperson of the Cell with regard to all questions of procedure shall be final.
- (i) The minutes of the proceedings of the Cell shall be drawn up by a member of the Cell and circulated amongst all members within a week.
- (j) Provided that any such minutes shall not be circulated if the Chairperson of the Cell considers such circulation prejudicial to the interest of the College.
- (k) The Principal of the Institute will review the working of the Cell on quarterly basis.
- (l) Every year new Chairperson and members shall be nominated by the Principal.
